Substitution and Re-Entry Starter or Substitute	A starter may be removed for a substitute BEFORE meeting MPR Any player who has been removed for a substitute may re-enter the game at any time in the SAME position in the batting order. A substitute entering the game for the first time may not be removed prior to completion of her/his mandatory play requirements, (3) defensive outs AND completed one time at bat.				A starter (including the DH) who has been removed for a substitute may re-enter the game once, provided such player occupies the same position in the batting order. A substitute (removed) may not re-enter.

Protests:	Playing Rule: Must be made before the next pitch/play/or attempted play. Ineligible Pitcher or Mandatory Play: Must be made before the umpires leave the playing field. Ineligible Player: When facts become known to complainant, but before the next game for either team. Improper Substitution: Protest not resolved before the next pitch or play shall not be considered.
